If the client already has a written safety compliance program in place, the FSR will review the safety program for enforcement and compliance.

The existing program may not adequately address historical sources of claims incurred by the client nor contain the necessary specific components for effectiveness. The client must commit and assist in this process. A specific site program, including a written safety program manual, is developed and prepared.

Safety & Health Program Components will vary according to the type industry you operate. Depending on the Hazard Rating of the client the initial worksite risk assessment and verification of worker's compensation codes may be required before a final contract for PEO services is presented to the client.

Hazard Analysis/ Needs Assessments/Safety Consultations & Recommendations

To begin the client-specific Safety & Health Compliance Program, the FSR will conduct a detailed analysis of the risks and hazards inherent to the client's facility and on the client's jobsites. The FSR will verify job duties and worker's compensation class codes assigned to each employee. When completed, this analysis and verification process helps reduce accidents, ensures job duties are in compliance with worker's compensation class codes and helps consolidate compliance efforts, and organize information.

Loss & Injury Analysis Reports/Annual OSHA 300 Logs/DOL Annual Accident Surveys

Conduct claims and loss analysis meetings with client and client supervisors for the purpose of preventing the recurrence of an accident. The basic components of a Safety/Hazard Analysis involve:

- Breaking each job into steps and proper methods
- Identifying and correcting hazards, important safety issues, and recommending procedures
- · Brief discussions of on-the-job training needs and requirements
- Employee involvement
- Assist the client in implementing a documentation program for all regulatory recordkeeping requirements.

A claims and loss analysis is provided to each client experiencing accidents and injuries.

Assist Client with regulatory audits, inspections, and appeals

Odyssey FSR's will conduct jobsite inspections for potential OSHA violations, unsafe acts, specific safety hazards or conditions. These inspections are required by our work comp carrier and the Texas State Department of Insurance. The FSR will schedule these on-site inspections with the client safety contact. Upon completion of the inspections the FSR will present recommendations to the client for eliminating hazards or for correcting possible OSHA/ regulatory non-compliance issues or conditions.

The FSR will also assist the client during an OSHA/regulatory agency audit or inspection and will assist the client in any regulatory appeals process should the client receive a citation or directive.

Initial organization of an on-site safety committee


The FSR will assist in the initial organization of an on-site company safety committee. The FSR will also periodically assist the committee in developing the company safety and health program.
